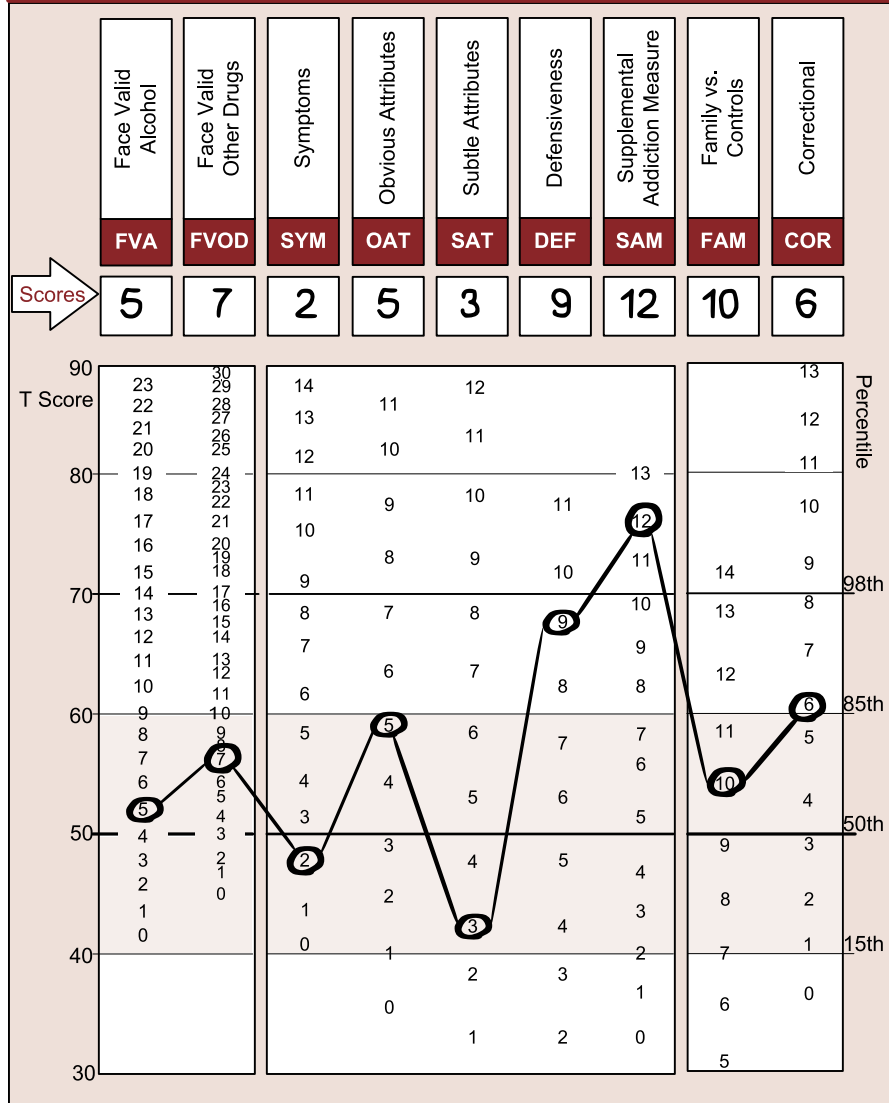

**LOW PROBABILITY**  
of having a Substance Use Disorder

Check if DEF is 8 or more \_\_\_\_\_ Elevated DEF scores increase the possibility of the SASSI missing individuals with a substance use disorder. Elevated DEF may also reflect situational factors.
